DIRECTIONS TO THE OWENEGO INN:

I-95 to Exit 54:

—Coming from New Haven, turn right at end of ramp onto Cedar Street

—Coming from Madison, turn left

Follow Cedar Street to Main Street.

Left onto Main Street, follow to traffic light at end of town green.

Right at light onto Route 146. Follow 146 for approx. 3 miles.

Right onto Linden Avenue, just beyond Lenny's Indian Head Restaurant.

The Owenego Inn is 1/4 mile on the left-hand side -- stone pillared entrance.
